- Admission into National Law Universities are based on CLAT Score
- Public Sector Undertakings recruit candidates based on CLAT Score

## How to Apply?

- Only online Application
- Application Fee
- General/OBC/PWD/NRI – Rs.4000/-
- SC/ST/BPL –Rs.3500/-

## Eligibility:

- For UG:
  - Should have completed 12th or its equivalent from recognised institution
  - Students appearing 12th are also eligible
  - Minimum marks in 12th standard
  - General/OBC/PWD/NRI/PIO/OCI – 45%, SC/ST – 40%
  - No upper age limit
- For PG:
  - Must have completed LLB (5year or 3year) from a recognised university
  - Minimum marks in LLB
  - General/OBC/PWD/NRI/PIO/OCI – 50%, SC/ST – 45%
  - No upper age limit

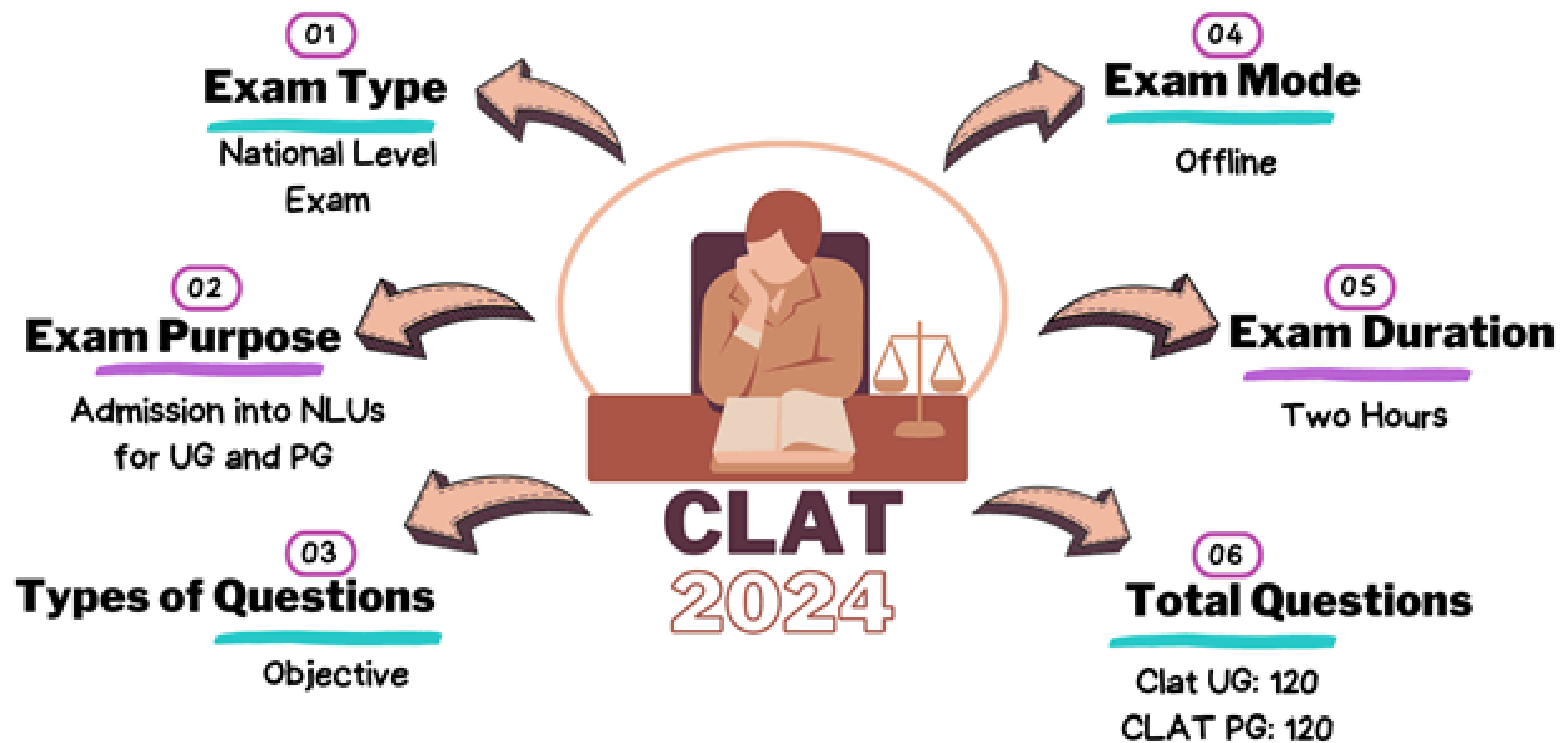
## Exam pattern

- Total Questions : 120 for both UG and PG
- Marking Scheme: +1 for correct answer and -0.25 for incorrect answer

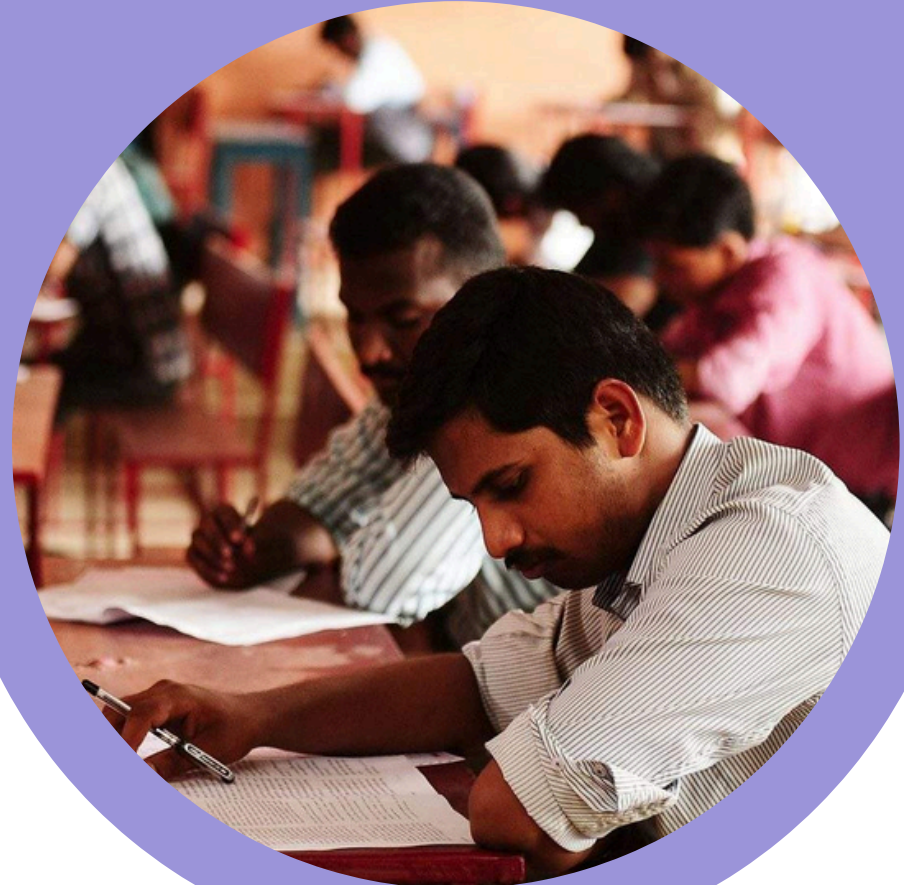
