ORDER:

The following announcement was made by the Hon'ble Minister for Labour in the floor of Assembly for the financial year 2016-2017:-

"கல்லூரி மற்றும் பல்கலைக்கழகங்களில் பயிலும் மாணவ/மாணவிகள் போட்டித் தேர்வுகளில் தேர்ச்சி பெற வசதியாக, பத்து அரசு கலை மற்றும் அறிவியல் பல்கலைக்கழகங்களில், கட்டணமில்லா வகுப்புகள் நடத்த ஐம்பது இலட்சம் ரூபாய் செலவில், போட்டித் தேர்வுகளுக்கான பயிற்சி மையங்கள், வேலைவாய்ப்பு மற்றும் பயிற்சித் துறையின் மூலம் அமைக்கப்படும்."

2. In the letter 2nd read above, the Director of Employment and Training has stated that at present coaching classes for competitive examinations are being conducted in all 32 District Employment Offices. The coaching centres will be set up in coordination with Higher Education Department in **Arts and Science Universities (Chemiai, Vellore, Salem, Coimbatore, Dindugal, Trichy, Madurai, Karaikudi, Thirunelvelli and Chidambaram)** to conduct coaching classes for poor students. The space and infrastructure required shall be provided in the university campus by Higher Education Department.

The details of expenditure are as below:-

The recurring expenditure for each centre shall be Rs.5,00,000/- (Rupees Five Lakh). A total cost of Rs.50,00,000/- (Rupees Fifty Lakh) is required annually for 10 centres.

- 3. The Government, after careful examination sanction the amount of Rs.50,00,000/- (Rupees Fifty Lakh only) per annum towards Free tuition classes for poor students in 10 Colleges and Universities for supporting their preparation and enabling their selection in competitive exams with the following terms and conditions:
 - a) The officer and staff of the centre will be deployed from the Department of Employment and Training (Employment Wing).
 - b) The infrastructure of Virtual Learning Centre with web based teaching and learning materials (Virtual learning system) will be utilized.
 - c) The University shall allot 1000 sq.feet space for setting up a centre and coaching class. The equipments required for the students to access the content uploaded for competitive examinations may be provided by the Universities. The existing language labs in the affiliated Government Colleges may be used for the content uploaded.
 - d) Coaching classes for competitive examinations will be conducted in the University campus after college hours and on holidays using resource persons identified from specific fields.
 - e) These classes will be conducted as and when vacancies are advertised by recruiting agencies.
 - f) The space and infrastructure required for the centre shall be provided by the Higher Education Department.
 - g) The recurring cost for running the centre, conducting coaching classes and deployment of man power will be borne by the Department of Employment and Training (Employment Wing). The District Employment Officer (youth employment service) may be deputed to the centre along with supporting staff (Junior Assistant / Typist/Junior Employment Officer / Office Assistant).

4) The above expenditure sanctioned in para 3 above shall be debited under the following Head of Account:-

- 5) The expenditure sanctioned in Para 3 above constitutes an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by sanction of an advance from the Contingency Fund, order regarding which will be issued by the Government in Finance (BG-I) Department separately. The Director of Employment and Training is directed to send necessary proposal to Government in Finance (BG-I) Department, in the prescribed format along with a copy of this order for sanction of advance from Contingency Fund for the amount actually required to meet the expenditure immediately during the current financial year.
- 6) This order is issued with the concurrence of Finance Department vide its U.O.No-18/DS(TS)/17, Dated 04.03.2017 and with Additional Sanction Ledger No.2252 (Two Thousand Two Hundred and Fifty Two)
