ORDER:

The College Students and Graduates Association of the Blind in their representation first read above, has requested the Covernment to reduces their following demands:-

- (i) To provide employment as BT Assistants to all those who have passed Teachers Eligibility Test (TET) conducted by Teachers Recruitment Board (TRB) and
- (ii) To provide employment as PG Assistants to 200 PG degree holders of Visually Impaired (VI);
- (iii) To provide employment to 100 Visually Impaired persons which have passed National Eliqibility Test (NFT) and State Eligibility Test (CCT) as Application (iv) To double the State of the State of
- (iv) To double the Readers Allowance amount given at present under various categories;
- (v) To Enhance the monthly Unomployment Reliet,
- (vI) 10 enhance the Scribe Assistance to Rs.300/-;
- (vii) To merge the Travelling Allowance (TA) amount of Rs.1000/- with the Basic Pay for Visually Impaired persons on Government of India pattern; and
- (viii) To fill up 500 mosts of a and B cotogorles as per Depreme Court adagment; and to conduct a special test for visually impaired persons by Tamil Nadu Public Service Commission.
- 2. The above demands were discussed in detail with the Hon'ble Chief Minister, senior Ministers and Minister for Social Welfare and Nutritious Meal Programme on 18.03.2015 and arrived decisions as follows:-
 - (i) The School Education Department will be requested to explore the possibility of providing employment to them in private schools and in respect of Government and Government aided schools through the Parent Teachers Association (PTA)

and for this the Government may offer salary subsidy to the extent of 25% of the salary will be paid to the visually impaired teachers. The scale of pay and Grade pay paid should not exceed Government scale of pay for the relevant category of teachers.

- (ii) During 2015-16, 988 PG Assistants will be recruited. By applying 2% reservation for Visually Impaired persons 19 PG Assistants can be appointed.
- (iii) During the year 2015-16, it is projected that 25 vacancies can be filled up by the visually impaired in Government Arts and Science Colleges, Technical Institutions

Efforts may be made to appoint qualified visually impaired persons as PG Assistants and Lecturers in Private Schools and Colleges by offering 25% salary subsidy. The scale of pay and Grade pay paid should not exceed the scale of pay and Grade pay for the relevant category of teachers in Government Schools and Government Colleges.

(iv) The Unemployment Allowance under each category may be enhanced as given below:-

- (v) The Scribe Assistance may be enhanced from Rs.250/- to Rs.300/-.
- 3. In the letter second read above, the State Commissioner for the Differently Abled has sent a suitable proposal on the above aspects and requested the Government to move with the School Education Department for providing employment to the qualified Visually Impaired B.T. Assistants in private schools and in respect of Government and Government aided schools through the Parent Teachers Association (PTA), by offering salary subsidy to the extent of 25% of the salary. Further, the Government may instruct the Teachers Recruitment Board to follow 2% reservation strictly for the Visually Impaired persons in the PG Assistants recruitment being made during the year 2015-16 and also requested to move with the Higher Assistants and Lecturers in Private Schools and Colleges by offering 25% salary subsidy.
- 4. The State Commissioner for the Differently Abled has further recommended the Government to enhance the Scribe Assistance from Rs.250/- to Rs.300/- and also recommended to enhance the Unemployment Allowance as follows:-

- 5. The recommendation of the State Commissioner for the Differently Abled has examined by the Government carefully and decided to accept the same and accordingly, issue the following orders:-
 - (1) The School Education Department is ordered to explore the possibility of providing employment to the qualified visually impaired candidates in private schools and in respect of Government and Government aided schools as B.T. Assistants through the Parent Teachers Association (PTA) by offering the salary

subsidy to the extent of 25% of the salary paid to the visually impaired teachers. The scale of pay and Grade Pay paid should not exceed Government scale of pay for the relevant category of teachers.

- The Teachers Recruitment Board is ordered to appoint 19 P.G. Assistants by (2)following 2% reservation for Visually Impaired persons while recruiting 988 P.G. Assistants during the year 2015-16.
- The School Education and Higher Education Departments are ordered to appoint (3)qualified visually impaired persons as PG Assistants and Lecturers in Private Schools and Colleges by offering 25% salary subsidy. The scale of pay and Grade pay paid should not exceed the scale of pay and Grade pay for the relevant category of teachers in Government Schools and Government Colleges.
- The Unemployment Allowance given under each category is enhanced as below:-(4)
